OPERATIONS

STAR HILL has modern vehicles that range from Toyota Land Cruiser V8/VX, Toyota Prado, Double Cabin Pickup, Toyota Rav4, Coaster (Mini Bus), Mini Van, Toyota Alphard and variety of Saloon Cars. All vehicles are fully airconditioned to Suit customer requirements.

OUR SERVICES



STAR HILL has a wide variety of Saloon cars. European luxury cars are also available in our fleet of cars. All our vehicles are fully air-conditioned to suit customers' requirements. We also offer self as well as chauffeur-driven automobiles to our customers.

This service involves delivery of the vehicles of choice to the customers with the accompaniment of a driver service and we charge a basic fixed rate per day for a minimum of 100km (exclusive of 18% VAT) excess kilometers are charged premium rates. The client who hires the vehicle from us does not pay for personal accident insurance premium and neither fuels the vehicle but in case the vehicle goes outside the city the driver/chauffer is to be paid Tsh.40,000 as allowance per day/night-out.

VIP TRANSFER SERVICES

These services involve the hiring of special luxurious chauffeur-driven automobiles of choice by the client or the client's host with the accompaniment of a well-trained highly groomed driver service. We charge a basic



fixed rate per day for a minimum of 100km (exclusive of 18% VAT); excess kilometers are charged premium rates. The client who hires the vehicle from us does not pay for personal accident insurance premium and neither fuels the vehicle. but in case the vehicle goes outside the city as agreed upon.

STAFF TRANSPORT SERVICES



STAR HILL Company Limited offer a special staff transport service that involves provision of staff transport to and from their homes to the various institutions that they work for, be they: factories, private companies, exhibitors, multi-national institutions, non-governmental organizations, diplomatic embassies, education institutions or any organization that
